SC/1 ELECTION OF CHAIRMAN

RESOLVED

SC/3 MINUTES

The minutes of the meeting of the Committee held on 14th March 2012 were approved as a correct record and signed by the Chairman.

SC/4 DECLARATIONS OF INTEREST

There were no declarations of interest.

SC/5 ANNOUNCEMENTS

The Chairman welcomed Selena Saroy, the recently appointed Senior Solicitor (Monitoring & Standards), to her first meeting of the Committee.

SC/6 MINUTES OF THE MEETING OF THE LOCAL ASSESSMENT SUB-COMMITTEES OF 4TH APRIL 2012

The minutes of the meeting of the Local Assessment Sub-Committee held on 4th April 2012 were received.

It was noted that the Chairman and the Monitoring Officer had conducted training with the Member concerned in relation to the Council's rules regarding the use of car parking permits by Members and the Code of Members' Conduct in general.

SC/7 STANDARDS COMMITTEE REPORTS AND DOCUMENTS AVAILABLE FOR INSPECTION

The list was noted.

SC/8 REPORT BY PARISH COUNCIL REPRESENTATIVES

Val Court advised that the Monitoring Officer had given a presentation on the revised Standards' regime at the most recent meeting of HALC.

SC/9 THE LOCALISM ACT 2011: UPDATE ON THE REVISED STANDARDS' REGIME AND CONSULTATION ON THE REVISED CODE OF MEMBERS' CONDUCT

The Monitoring Officer reported that the Localism Act 2011 made fundamental changes to the system of regulation of standards of conduct for elected and co-opted Councillors and the new provisions were likely to come into force on 1st July 2012, although he Order from the Secretary of State was still awaited. The Chairman of the Council had set up a cross party Standards' Liaison Group to work up proposals to enable the Council to comply with the new provisions in the Act, which had been meeting on a monthly basis since December 2011.

As a result of the work of the Group, on 22nd February 2012, the Council had agreed the appointment of one Independent Person and one reserve Independent Person to comply with new statutory provisions and, on 15th May 2012, it had agreed the appointment of a new Standards Committee, arrangements for dealing with Code of Conduct complaints for both district and parish councils, changes to the Constitution, a revised Dispensation Scheme and that the revised Code of Conduct should largely reflect the current code in particular the behavioural aspects contained in paragraphs 3-7.

Recommendations would be made to the Council on 27th June 2012 on the detailed content of the new Code of Members' Conduct to be adopted and the views of this Committee were sought in that respect.

SC/9 <u>The Localism Act 2011: Update on the Revised Standards' Regime and</u> <u>Consultation on the Revised Code of Members' Conduct (cont.)</u>

Details as to what had to be included in the new Code were set out in section 28 of the Localism Act 2011. The Act provided that an adopted code, when viewed as a whole, had to be consistent with the principles of selflessness, integrity, objectivity, accountability, openness, honesty and leadership. In addition, the Council had to ensure that its code included provisions the authority considered appropriate in respect of the registration in its register and disclosure of both pecuniary interests and interests other than pecuniary interests.

The Monitoring Officer reported on the history of the Code of Members' Conduct and submitted, for Members' information, the 1974 Code, the National Code of Conduct adopted in 1989, the current Code of Members' Conduct and various templates and illustrative texts that had been prepared by the Local Government Association; the Department of Communities & Local Government; a working group of East and West Sussex District and Borough Council officers; West Sussex County Council; and the National Association of Local Councils.

The Localism Act would also abolish the statutory concepts of personal and prejudicial interests and, instead, regulations would define a new interest called "Disclosable Pecuniary Interests" (DPIs). At present the regulations had not been published but it was considered that DPIs were likely to be broadly equivalent to the current prejudicial interests. It was intended that the revisions to the Register of Interests would also be presented to the Council on 27th June 2012.

The report before the Committee had also been considered by the Chairman's Standards' Liaison Group and Councillor Claire Vickers updated Members on the views of that Group, indicating that the preference had been for the new Code to be as close as possible to both the existing one and that adopted by the County Council. It was also hoped that Parish Councils would adopt this Council's model Code, as the Monitoring Officer would continue to be responsible for dealing with Standards issues arising from the 32 parish councils within the District.

The Committee also considered that a Code as close as possible to both the existing one and that adopted by the County Council would be preferable, both from the point of view of ease of transition and also for the benefit of Members who sat on more than one authority (e.g. District and County or District and Parish). For this reason, it was also considered that the parish councils within the District should be encouraged to adopt the same Code as that eventually adopted by the District Council. Members of the Committee also discussed the composition of the Standards Committee and its subcommittees that would replace the existing Committee when the new Standards regime commenced.

SC/9 <u>The Localism Act 2011: Update on the Revised Standards' Regime and</u> <u>Consultation on the Revised Code of Members' Conduct (cont.)</u>

RESOLVED

- (i) That the matters set out in the report be noted.
- (ii) That it is the view of this Committee that the new Code of Members' Conduct should be as close as possible to both the existing one and that adopted by the County Council and that the parish councils within the District should be encouraged to adopt the same Code as that eventually adopted by the District Council.

REASONS

- To ensure Members of the Council and others to whom the report is circulated are kept up to date with developments flowing from the Localism Act 2011 in relation to standards and member conduct.
- To comply with the statutory obligations placed upon the Council and its Members set out in Chapter 7 of the Localism Act 2011.

The Local Government Ombudsman Annual Review 2011-2012

Executive Summary

This report is to update Members on the developments of the number and nature of complaints about the Council made to the Local Government Ombudsman (the "LGO"). It provides the statistics for the period 01 April 2011 and 31 March 2012, together with details of the LGO's Annual Review for the same period.

Recommendations

The Committee is recommended to note the contents of the report.

Reasons for Recommendations

- i) To ensure that the Committee has the necessary information to ensure that complaints can be made to the Council with ease and complaints are dealt with appropriately.
- ii) To assist with establishing learning lessons so that the Council can improve its performance in the provision of its services.

Background Information

1 Introduction

The purpose of this report

1.1 The purpose of this report is to update Members on the number, nature and the present position of complaints about the Council to the LGO, and provide details of the LGO's Annual Review Letter.

Background/Actions taken to date

- 1.2 The LGO requires complainants to exhaust the Council's internal complaints procedure. In the event that the LGO receives a complaint that has not first been processed internally by the Council, it will refer the complainant to the Council's internal complaints procedure. The LGO then logs these complaints as "premature complaints".
- 1.3 Details of all complaints, compliments and suggestions to the Council are considered by the Performance Management Working Group on a quarterly basis.

2 Statutory and Policy Background

Statutory background

- 2.1 The statutory background is found in the Local Government Act 1974 (as amended) and the Local Government and Public Involvement in Health Act 2007.
- 2.2 The Local Government Act 1974 (as amended) specifies the two main statutory functions for the LGO:
 - 2.2.1 To investigate complaints against councils and some other authorities; and
 - 2.2.2 To provide advice and guidance on good administrative practice.
- 2.3 The Local Government and Public Involvement in Health Act 2007, also sets out the LGO's role:
 - 2.3.1 The LGO may look at service failure in addition to maladministration;
 - 2.3.2 The LGO will have a limited power to investigate where an apparent case of maladministration comes to light even though they have received no complaint about the matter;
 - 2.3.3 Complaints about the procurement of goods and services are now within jurisdiction;
 - 2.3.4 The LGO may issue a 'statement of reasons' instead of a report if they are satisfied with the council's proposals to remedy its failures;
 - 2.3.5 There are new powers to publish the LGO's decisions other than reports; and

2.3.6 Complaints no longer need to be in writing.

Relevant Government policy

2.4 The relevant Government policy is contained in the legislation cited in paragraph 2.1 above.

Relevant Council policy

2.5 The Council's Complaints Procedure for handling comments, representations, criticisms of policy and formal complaints is set out within Part 5D of the Council's Constitution.

3 Details

Annual Review 2011-2012

- 3.1 The Council has received the LGO's draft Annual Review letter, which sets out its provisional complaint statistics. The LGO is due to finalise its Annual Review Letter and send to the Council in late June 2012. The final copy of the LGO's Annual Review letter normally comprises two sections. The first section provides a general update on LGO developments and the second section focuses on the complaints that the LGO receives about the Council's services.
- 3.2 Complainants referred to within the LGO's report and the Annual Letter, when published, will be anonymised in compliance with Part 1 Schedule 12A of the Local Government Act 1972, as it forms information relating to individuals.
- 3.3 The LGO prepares annual statistics for the period of 01 April to 31 March each year. The LGO has provided the Council with provisional statistics for 2011/12 and the final statistics for 2011/12 will be published.
- 3.4 The LGO can make recommendations to the Council in regards to remedying the complaint against its service, including an apology from the Council and compensation payments. In 2011/2012, the LGO did not recommend any compensation payments.
- 3.5 The LGO's provisional statistics indicate that since 01 March 2011, fifteen complaints were made to the LGO, and whilst eight were deemed premature complaints, the LGO may have subsequently investigated where the Council then completed its own internal complaints procedure. For this reason, there is an overlap in the statistics provided, but overall the LGO received fifteen complaints about the Council's services; five fewer complaints than were received in 2010/2011.
- 3.6 The complaints received against Council departments are as follows:
 - 3.6.1 Two complaints about the Benefits and Tax team;
 - 3.6.2 One complaint about Strategic Land & Property;
 - 3.6.3 One complaint about the Environmental service, Public Protection and Regulation teams;

- 3.6.4 One complaint about the Housing team; and
- 3.6.5 Ten complaints about the Planning and Development teams.
- 3.7 The LGO issued investigative decisions in nine complaint cases and determined that:

- 3.8 An updated schedule of cases recorded for the 2011/12 reporting year is attached (SC451/SC471).
- 3.9 The average time taken by the Council to reply to the Ombudsman's written enquiries was 31.0 compared with 23.5 days last year. The target response time is 28 days. The Council exceeded the target response time, as a result of delays in receiving the relevant information from service areas.

4 Next Steps

- 4.1 This report is based on the provisional statistics that will be recorded in the LGO's final copy of its Annual Review letter. It is intended that this report is to assist with learning lessons and improve performance, following complaints made to the LGO about the Council.
- 4.2 The LGO's Annual Review Letter shall be published upon receipt.
